

Monthly, we send you an updated social media guide on the High Impact Practices in Family Planning (HIPs) with the purpose of (1) increasing awareness and use of the HIP briefs, and (2) generating traffic on the HIP website. Please share!

This month's social media messages are focused on the recently updated brief titled: Leading and managing: for rights-based family planning programs. Leadership and management issues were perceived as "essential elements for scaling up locally driven family planning programs" among participants across tiers of local health governance. The brief highlights 8 practices for effective leadership and management that organizations can adopt to improve their programs. Introducing leadership and management practices creates an improved work environment which enhances health worker motivation and agency, better healthcare performance, and improved capacity for programs to respond to changing community needs and effectively scale up. The brief also highlights successful leadership and management interventions and includes tips and resources for implementation.
